2.3 The 24th AJAFA-21 ECM 2012 VACYF, the host of the 24 th ECM, reported the current status of ECM preparation. The 24 th ECM will be held in Hanoi from 17-20 February 2012. The members discussed about the theme/issue that will be shared during the ECM which finally agreed to elevate the important of young generation. Therefore, the topic in the 24 th ECM will be "How to solve the human resource development (HRD) problem among ASEAN countries and how to train those people". Regarding this, VACYF will send the invitation letter to each alumni association by 18 January 2012. JICA Vietnam Office will also send the invitation letter to JICA Offices in each country. The invitation letter will be sent to each alumni association by 18 January 2012 as well as JICA Offices in each country.
